# Definition of Family

- All our products include Bulgarian citizenship and passport for the applicant and the immediate family.
- The term “family” is defined by husband, spouse and children of any age.
- The parents of the applicant are not covered under “family”.

**Note:**

We offer a solution which also includes parents as an additional part of the product.

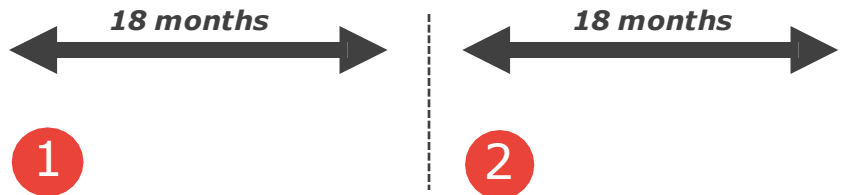
# Order of Applications

There are four simple rules which define the order of the applications:

1. Usually the husband becomes the main applicant and commences the application procedure first.
2. As soon as the main applicant has received Bulgarian citizenship, the application procedure for the spouse, the children and their children of any generation commences.
3. The application procedure of spouses of children of any generation only commences when their husband has received Bulgarian citizenship.
4. In any case, any spouse will be granted with Bulgarian citizenship, on the condition of being married for at least 5 years.

# Case Study I

The applicant is a 50-year old male (husband). He has a spouse and two children aged 15 and 10.



1. The applicant applies for EU citizenship via one of our fast track products. He receives his Bulgarian passport in 18 months.
2. After the applicant has received his Bulgarian passport, the spouse and the two children apply for EU citizenship. Within 18 months (within a total of 36 months including step 1) the spouse and the children receive their Bulgarian passports, at no additional cost.

# Case Study II

The applicant is a 50-year old male (husband). He has a spouse and two children aged 20 and 15. The applicant wishes to provide his parents with EU citizenship as well.

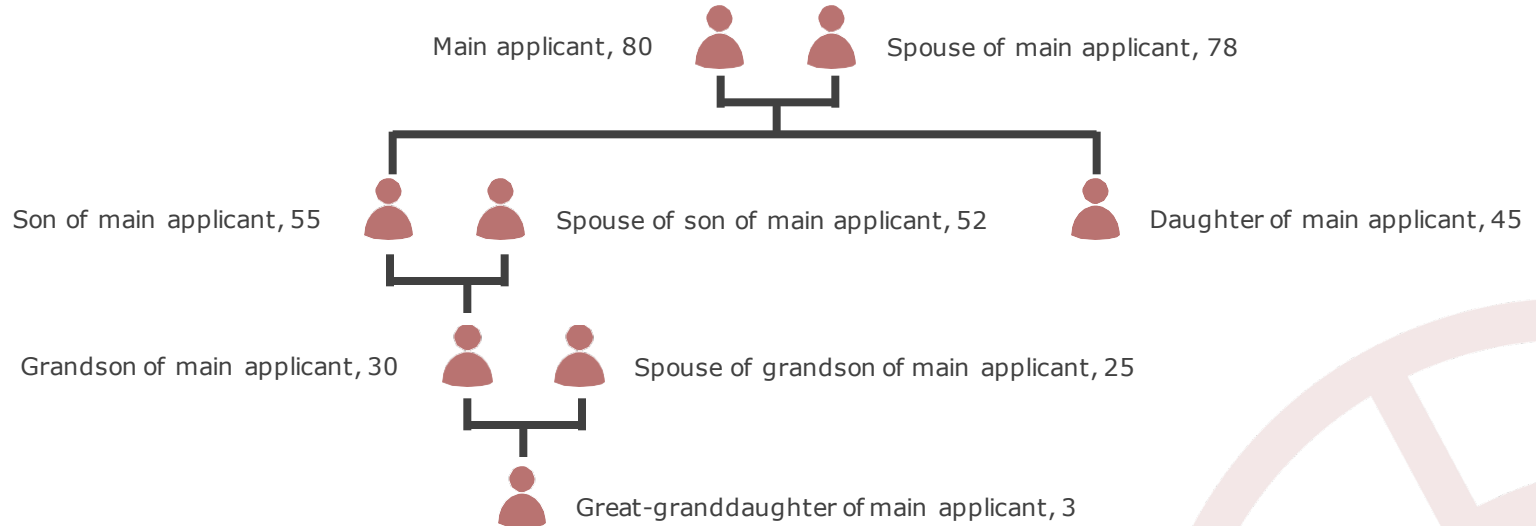


1. The husband's father applies as the main applicant for EU citizenship via one of our fast track products. He receives his Bulgarian passport in 18 months.
2. After the main applicant has received his Bulgarian passport, his spouse, the son (husband) and the two grandchildren (children of the husband) apply for EU citizenship. Within 18 months (within a total of 36 months including step 1) the spouse and the children receive their Bulgarian passports.
3. Only after the husband has received Bulgarian citizenship, his spouse applies for EU citizenship. She receives her Bulgarian passport within 18 months (within a total of 54 months including step 1 + 2). Please note that we only charge EUR 10,000 for each application of the husband's spouse, and their two children, as these family members are not covered under immediate family (see slide "Definition of Family").

In summary; within 54 months, the husband's parents, the husband, his spouse and children, have received EU citizenship by investing in only one product, while saving a considerable amount of money.

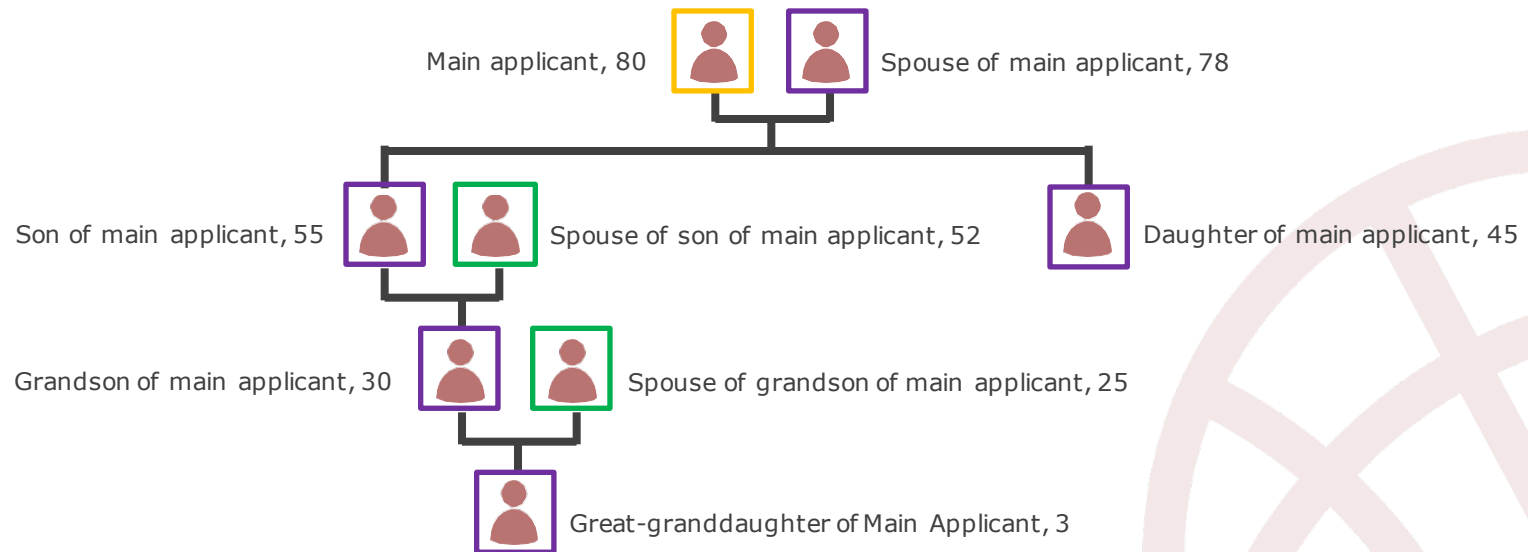
# Case Study III/I

The main applicant is an 80-year old male. He has a spouse aged 78, and two children aged 55 and 45. The eldest child has a spouse aged 52, and a son aged 30. This son has a spouse aged 25, and a daughter aged 3.



# Case Study III/II

1. The main applicant applies for EU citizenship via one of our fast track products. He receives his Bulgarian passport in 18 months (orange).
2. After the main applicant has received his Bulgarian passport, his spouse aged 78, his son aged 55, the grandson aged 30, the great-granddaughter aged 3, and the daughter aged 45 apply for EU citizenship. Within 18 months (within a total of 36 months including step 1) they all receive their Bulgarian passports (purple).
3. The two spouses of the main applicant's son, and grandson, can only apply for Bulgarian citizenship when their husbands have received their Bulgarian passports (green).



# Case Study III/III



1. The main applicant applies for EU citizenship via one of our fast track products. He receives his Bulgarian passport in 18 months.
2. After the main applicant has received his Bulgarian passport, his spouse and all family members in the direct blood line of the next three generations receive their Bulgarian passports within 18 months.
3. After their husband (son and grandson of main applicant) has received Bulgarian citizenship, the two spouses apply for EU citizenship. They receive their Bulgarian passports within 18 months (within a total of 54 months including step 1 + 2).

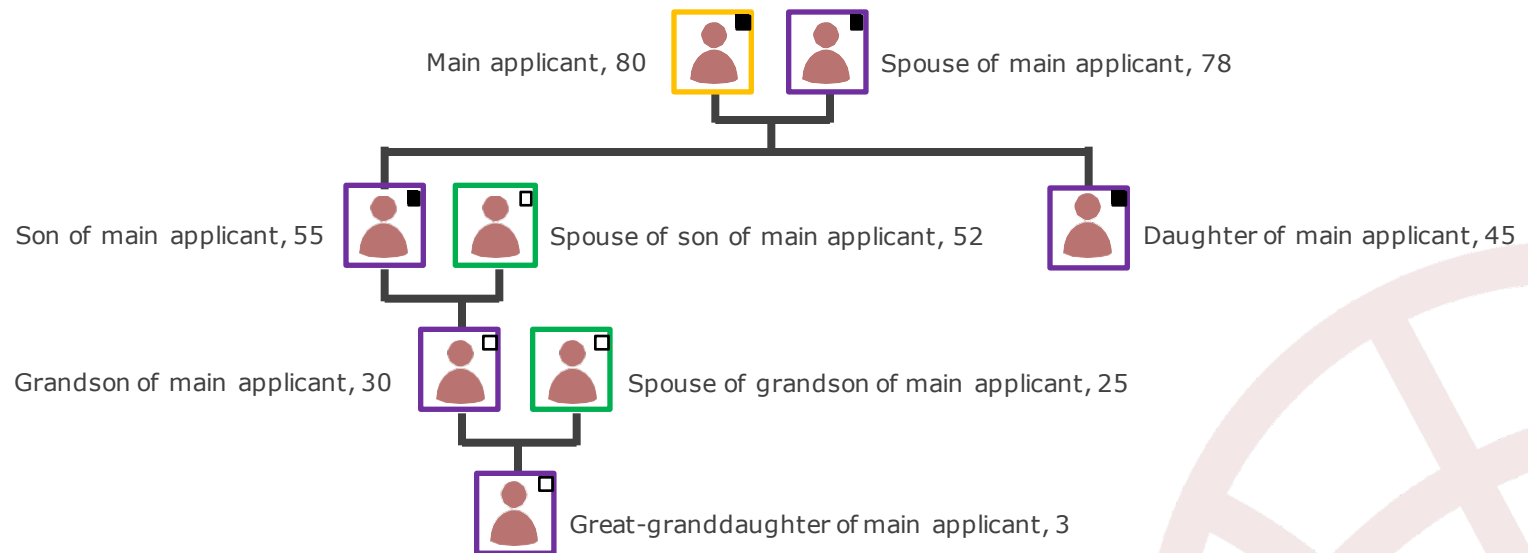
In summary; within 54 months, the husband's parents, the husband, his spouse and children, have received EU citizenship by investing in only one product, while saving a considerable amount of money.



# Case Study III/IV

Please note that we only charge EUR 10,000 for each application which is not part of the immediate family (see slide "Definition of Family").

- Immediate family; husband, spouse, and children of any age are included in any of our products.
- Non-immediate family; EUR 10,000 is charged for each application.



# Solution to Much Faster Processing

- Choosing a “Two Main Applicant” product (Financing, Property, or Life Insurance), will considerably shorten the process.
- With a “Two Main Applicant” product, both partners of a legally married couple can apply simultaneously.
- Husband and spouse will receive their EU / Bulgarian citizenship at the same time while the children will receive their citizenship within the next 18 months.
